Prizes are awarded as is, no substitutions, exchanges, or cash value will be awarded.

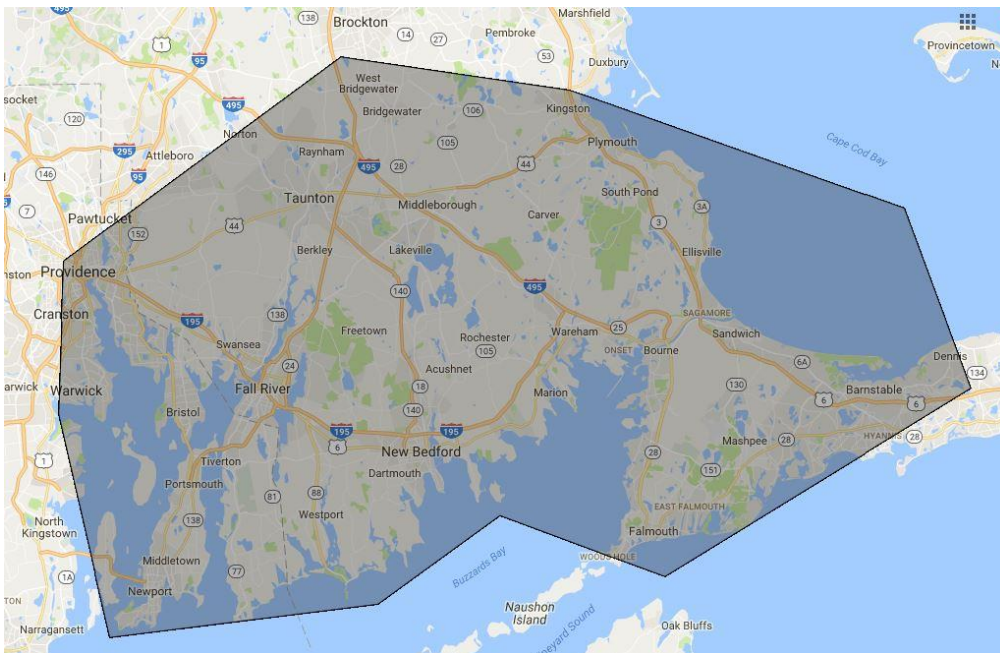
