



## 2020 OFFICIAL RULES FOR CARE FREE HOMES HARVEY WINDOW SWEEPSTAKES

### OFFICIAL RULES

**NO PURCHASE OR PAYMENT NECESSARY TO ENTER OR WIN, AND IN NO WAY WILL A PURCHASE IMPROVE THE CHANCE OF WINNING.** The “Care Free Homes Harvey Window Sweepstakes” (referred to herein sometimes as the “sweepstakes”) sweepstakes is sponsored by Care Free Homes, Inc. (“Sponsor”) This sweepstakes is governed by these official rules (“Official Rules”). By participating in the sweepstakes, each entrant agrees to abide by these Official Rules, including all eligibility requirements, and understands that the results of the sweepstakes, as determined by Sponsor and its agents, are final in all respects.

**ELIGIBILITY:** Sweepstakes is open to residents of Southeastern Massachusetts, Upper and Mid Cape Cod, and Eastern Rhode Island within the Care Free Homes service area as indicated on the map below who are 18 years or older—excluding employees, families or affiliates (or those with whom they are domiciled) of Care Free Homes. Winner must be the homeowner of the property work is to be performed on. Ownership is defined by winner’s name on existing mortgage or recent tax bill of the property.

By entering, entrants release and agree to indemnify and hold harmless Care Free Homes and its directors, officers, employees, affiliates, agents, contractors, dealers and advertising and promotional agencies from any and all damages, injuries, claims, causes of actions, or losses of any kind (including actual legal fees and expenses) (whether under legal theories of contract, tort, negligence, strict liability, operation of law or otherwise) resulting from participation in the sweepstakes.

The sweepstakes is subject to all federal, state and local laws and regulations and is void where prohibited by law. This sweepstakes is in no way sponsored, endorsed or administered by, or associated with, Facebook, Twitter or any other social media platform. Any questions, comments or complaints regarding the promotion will be directed to Sponsor directly.

**HOW TO ENTER:** The Care Free Homes Harvey Window Sweepstakes commences on March 30, 2020 and ends on October 31, 2020 with entries to be submitted by 9:00 PM EST on October 31, 2020 (the “sweepstakes Closing Date”). Sweepstakes Administrator’s computer will be official timekeeper.

Completely fill out the entry form, including your email address, first name, last name, and checkbox to agree to Sweepstakes rules, then click the “Enter Sweepstakes” button. One entry per individual in total.

Individuals can also completely fill out a paper entry form available at Care Free Homes offices at 239 Huttleston Ave, Fairhaven, MA 02719 or at various Care Free Homes displays and events. One entry per individual in total.

**Sweepstakes DRAW:** One (1) winner will be selected by Care Free Homes, Inc. (“Care Free Homes”) from among all eligible online and paper entries received in a random drawing conducted at the offices of Care Free Homes at or around 9am EST on November 2, 2020. Odds of winning depend on the total number of eligible entries received on or before the sweepstakes Closing Date.

ACTUAL RETAIL VALUE: Prize consists of a one-time order by the winner for the supply and installation of the following services up to a total retail order not to exceed \$3800 in value:

#### Prize/Windows

Prize includes five (5) Harvey Elite Double Hung replacement windows (less than 101 united inches) with professional installation by Care Free Homes, Inc.

Care Free Homes services for the winner's home will have a total retail value not to exceed \$3800. Prize must be redeemed and the installation completed no later than December 1, 2020 (except delays caused by Care Free Homes). The prize must be redeemed for the services stated above up to a total retail value not to exceed \$3800, and no replacement or substitute services will be offered, except in Care Free Homes sole discretion. The prize has no (\$0.00) cash redemption value. To the extent the winner does not use the full retail value of the prize up to \$3800 on the installation services expressly stated above, the winner will not receive any remaining cash redemption value on the prize. Care Free Homes, at its discretion, may substitute any Prize for equal or greater value. If the winner cannot be reached within 10 days, or fails to complete and return the required sweepstakes documents, within 14 days after the document is emailed, they will forfeit the prize and an alternate entrant will be randomly selected.

PRIVACY: Care Free Homes will not share entrant information provided on entry forms with third parties except as needed to run and promote the results of this sweepstakes. Unless an entrant indicates otherwise on the entry form, Care Free Homes may use the entrant's e-mail address and other contact information to send them Care Free Homes promotional material through email or mail. You may choose to unsubscribe to our email list at anytime.
